Village of Bancroft Regular Meeting May 3, 2021

The regular meeting of the Village Board of Bancroft was convened in open and public session on Monday, April 5 at 7:00 p.m. Present: Trustees: Peirce, Rief, Soll, Bargmann and Hermelbracht. Also present is Chief of Police Davis and other interested persons.

Advance notice of the meeting was published in the Wisner News Chronicle on March 31, 2021. Proof of publication is being attached to these minutes.

Chairperson Hermelbracht called the meeting to order and stated that a copy of the "Open Meetings Act" was on display in the meeting room.

Motion was made by Peirce, seconded by Rief to approve meeting minutes from the March 1, 2021 meeting. RCV: Ayes; Bargmann, Rief, Peirce, Soll and Hermelbracht.

Motion was made by Bargmann, seconded by Peirce to approve meeting minutes from the March 10, 2021 special meeting. RCV: Ayes; Rief, Peirce, Bargmann, Soll and Hermelbracht.

Planning commission recommended to pass Ordinance No. 470 that amends the definition of home occupation to permit the business to be carried on by someone other than the person who uses the dwelling as a private residence. This amendment was brought up because a hair salon owner purchased a property next to their home in the R-1 zoning district and wants to move their business to that residence they purchased. She will not be living in the home with their business and the current R-1 zoning states the person who lives in the home can open a business in their house. Since the business owner would not be living in the property, two options were given by the village attorney Munderloh. This ordinance would still require the business owner to apply for a conditional use permit before work is done. So once this ordinance is passed the business owner will have to apply for a conditional use permit and have it approved by the village board. Question was brough up by trustee Rief if this would pertain to any person who wants to open a business in a residence. Clerk Novak explained that the zoning ordinance for R-1 already allows a homeowner who lives in the residence to run a business out of there home. This new ordinance allows someone other than the homeowner to open a business in a residence. The only other option was to rezone the property to C-1 which would allow any person to open a business on that property.

Motion was made by Peirce, seconded by Rief to waive the three readings of Ordinance No. 470. RCV: Ayes; Rief, Peirce, Bargmann, Soll and Hermelbracht.

Motion was made by Rief, seconded by Peirce to approve Ordinance No. 470. RCV: Ayes; Peirce, Bargmann, Soll, Rief and Hermelbracht.

AN ORDINANCE OF THE VILLAGE OF BANCROFT, NEBRASKA, AMENDING SECTION 8.2 AND THE DEFINITIONAL SECTION OF THE VILLAGE'S ZONING ORDINANCE TO DEFINE "HOME OCCUPATION" TO PERMIT THE BUSINESS TO BE CARRIED ON BY SOMEONE OTHER THAN THE PERSON WHO USES THE DWELLING AS A PRIVATE RESIDENCE; REPEALING ALL ORDINANCES, RESOLUTIONS, CODE SECTIONS, AND PARTS THEREOF IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.
